It has been represented by the Unions that Board's Memo. dated 19.01.2017 under reference third cited the retired employees would be affected and it will lead to huge recovery from the retired Supernumerary Inspectors of Assessment and have requested to cancel the order dated 19.01.2017, allowing the Supernumerary Inspectors of Assessment another increment on their regular promotion as Inspector of Assessment.

After careful examination it is hereby ordered that the orders issued in the Board's Memo. dated 19.01.2017 stands cancelled and the Supernumerary Inspectors of Assessment be allowed another increment notionally on their regular promotion as Inspector of Assessment as ordered in Boards Memo. second cited.
